2. Old Business

The Book Club led by Karen Riddick is going well. They seemed to have worked out all the kinks and things are running smoothly. The Book Club meets the 2nd Wednesday of every month at 10am at the senior center in Barco. Albemarle Senior Games applications are now available at the Senior Center. Past participants should have received their applications by mail. Senior Games applications can be turned in at the senior center as an alternative to mailing them. The Bell Choir has had several performances including the Whalehead Club, Shawboro Ruritan Club, Currituck House & more. They will be performing at the Currituck House again on February 20th. The senior center received many donations for Santa for Seniors and Food Baskets for the Elderly this recent holiday season. The Alzheimer's Support Group meets the 3rd Thursday of every month at the senior center in Barco. Group facilitator Ellie Galloway mentioned that she has lost a few members since the group began and is working to ensure that information about the group is still being pushed out into the public with flyers, The Alzheimer's Association website and information printed in the Senior Center newsletter.

Currituck EMS is doing outreach in the community by offering "Good Samaritan" (non-certified) CPR Cardiopulmonary Resuscitation/First Aide classes. Stacy is working on the 2026-2027 Budget. Stacy added that the Citizens Academy is a great way to educate the public on what our department does with accurate information. The March for Meals Campain with Albemarle Commission is approaching. The March for Meals campaign brings awareness to the Home Delivered Meals program by using public figures to deliver meals.
